ALL Applicants must have a Washington State Business License (UBI #). Please make sure this is included in your application. PLEASE also make sure you give us a good email address that you check and have access to – this is how we will be sending you much of your Merchant information and answering your questions!

Assignment of booth space and location is at the discretion of the RSPD 2018 Committee, and is largely determined by need, type of wares, and seniority. We will advise people both of their acceptance, and their apx location as soon as possible, but location cannot be determined until June of 2018.
